## 2010 Recumbent Rally Waiver

In consideration of being permitted to participate in the Midwest Recumbent Rally I, personally, and on behalf of my heirs, personal representatives, successors and assigns, specifically agree to assume any and all risks of injury and death which may be associated with my participation in the Midwest Recumbent Rally. I, personally, and on behalf of my heirs, personal representatives, successors and assigns, hereby release, waive, discharge and covenant not to sue all organizers, promoters, sponsors, participants and all other persons and associations connected with the Midwest Recumbent Rally including but not limited to the Hostel Shoppe, Ltd., and all of their officers, directors, agents, employees, predecessors, successors and assigns (hereinafter referred to as the released parties) for any and all injuries or damages of any kind whatsoever including death suffered by me as a result of my participation in the Midwest Recumbent Rally including but not limited to injuries, damages and/or death caused by the negligence of the released parties. I hereby acknowledge that the Hostel Shoppe has advised me and/or my children to wear an ANSI or Snell approved helmet. I understand that there are additional risks of injury or death involved in riding without a helmet, and I freely assume all those additional risks.
